- ❖ Timely and qualitative implementation of tasks set for the statistical bodies for 2023 from the "National Action Plan to Strengthen the Fight Against Corruption for 2022-2026";
- ❖ Taking necessary measures for timely and qualitative implementation of tasks outlined in the "Azerbaijan 2030: National Priorities for Socio-Economic Development";
- Providing statistical information support for the timely and qualitative implementation of the duties outlined in the "Transforming our world: the 2030 Agenda for Sustainable Development";
- Conduction of Multiple Indicator Cluster Survey (MICS);
- Maintaining the improvement of activity of local statistical bodies where QMS is applied in accordance with ISO 9001:2015 international standard requirements and application of QMS in other local statistical bodies;
- Minimizing errors on primary and final data and increasing data quality through improvement of quality control mechanisms;
- Continuing implementation of digitalization of statistical processes and QMS;
- Continuing implementation of DESAP self-assessment questionnaire by the structural units of the State Statistical Committee;
- ❖ Taking relevant measures for development of national statistical classifications system in line with international standards;
- Taking measures to get wider user audience through dissemination of data and metadata according to relevant standards and keeping actuality;
- Taking necessary measures to expand the possibilities of using administrative data obtained from government agencies in the official statistics;
- Reducing respondents' data burden by increasing the possibilities of using administrative data for official statistical purposes;
- Taking relevant measures toward production of new statistical products considering user demand;
- Finalizing the development of E-learning portal and submitting into use;
- Continuing implementation of actions on provision of public access to official statistics on extractive industries transparency;
- ❖ Timely and qualitative implementation of tasks for 2023 outlined in the "Communication Strategy of the State Statistical Committee of the Republic of Azerbaijan for 2022-2023";
- \* Carrying out relevant works on the implementation of communication activity during crisis situations;
- ❖ Studying user needs through surveys and ensuring maximum users' satisfaction;
- ❖ Further extension of relations with mass media as well as improving communication activity through social media;
- Analysis of activities of the local statistical bodies and provision of information to the management of the State Statistical Committee;
- Taking necessary measures toward strengthening capacity of the local statistical bodies;
- ❖ Implementation of necessary works to maintain and improve the functioning of the information security system, to increase focus on this direction according to "Manual on provision of information security in the State Statistical Committee of the Republic of Azerbaijan";
- Continuous update of ICT equipment and software of the statistical system.
