Results on works of State Statistical Committee

In 27 January, 2012 it was carried out wide board meeting at the Administrative Building of the State Statistical Committee on works of statistical bodies in 2011. The heads of Apparatus, Statistical Committee of Nakhchivan Autonomous Republic, Main Computing Centre, regional statistical offices were participated in the board meeting. To speak about the activities of Committee the word was given to the head of Department on Coordination of Statistical Works, member of the board Mr. A. Mansurov. He was noted that works on direction of implementation of statistical system in the country, which forms the basis for the development of the "2008-2012 State Program on improvement of official statistics in the Republic of Azerbaijan", as well as the participation of the State Statistics Committee, as the main executor of the work specified in the implementation of other state programs have been continued. Thus, connected with the State Program on Improvement of Official Statistics of the Republic of Azerbaijan in 2008-2012 during 2011 31 works were carried out, during 4 years – 170 works. On other State programs 12 works were carried out in reporting period.

The "Law of the Republic of Azerbaijan on amendments to the Law of the Republic of Azerbaijan on "Official statistics" was approved.

In order carrying out Constitutional Law of the Republic of Azerbaijan on "Normative legal acts" Article 1, paragraph 1.0.22 has started registration of technical normative legal acts approved by the State Statistical Committe in the State Register of Legal Acts of the Republic of Azerbaijan created in the Ministry of Justice.

During the reporting period one of the activities of the State Statistical Committee has been applied a new quality management system (QMS). According to the demands of document collection on "Quality management system" approved by the Board of Committee, in 2011 Industry, Transport and Communication Department and Price Statistics Department initiated and successfully completed the implementation of quality management system.

In 2011 cooperation with international organizations and statistical bodies of other countries were further developed, 70 specialists of Committe were participated in the conference, seminars and other measures organized by them.

The works were continued within the framework of the Twinning Program of the European Neighbourhood Policy, the conference devoted to its results was carried out on 10-11 November, 2011. The results of project were highly appreciated by the representative of Avrostat and other participants.

Also the State Statistical Committee used from the opportunities of TAIEX (Technical Assistance and Information Exchange) program and seminars were organized within the framework of the program. The article on development of energy statistics in Azerbaijan published in the news bulletin of UN Statistics Division No 7/8 in December, 2011.

In order to ensure the execution of the Decree No 429 dated 23.05.2011 of the Republic of Azerbaijan "On some measures for organization of e-services realized by state bodies created a new section "Electron Services" in the web page http://www.azstat.org of the State Statistical Committee.

In 2011 by the purpose of improving working conditions of employees of the local statistical bodies the construction of new office buildings have been completed in Ganja city, Agstafa, Hacigabul, Gusar and Zagatala regions.

The structure of the Apparatus of the Committee has been improved in order to adapt the structure of other countries and creation of the works of the Committee to the level of modern requirements.

At the end of the meeting the chairman of the State Statistical Committee Mr. Arif Valiyev in his wide range speech noted about the works carried out in 2011 and about future tasks in 2012.
